For over 160 years the Freemasons of Victoria have given generously and in the last few years we have made great strides in making our contribution to Victorian Society, even more substantial, through the amazing work of our lodges, supported by Freemasons Foundation Victoria Limited. This work could not be possible, without the remarkable efforts of the Directors and Committee Members of the Foundation, who give their time and professional experience to work as a team, to ensure the Foundation is in a very strong position to support these efforts. I therefore take this opportunity to thank them for all of their efforts in achieving remarkable outcomes over the last twelve months.

The Brethren have found many ways to support the communities in which they live. Indeed over the last 12 months, hundreds of large and small donations have been made, across the entire state. Scholarships totalling over \$350,000 to students at secondary and in our Universities, reflects the importance we place on education, in developing the next generation to achieve their goals. From giving a much needed injection of financial aid to Support After Suicide in Geelong, to providing desperately needed support by giving 12 trucks loaded with stockfeed for drought impacted

farmers in Gippsland and helping create a new Hospital facility in Swan Hill, the initiatives are a testament to the generosity of spirit which is a feature of all Freemasons.

In total for 2018-2019 over \$3.1m was distributed to the Victorian Community by the Foundation and as we approach 5 years since the Foundation was established, so the fantastic amount of \$10m will have been given to deserving causes.

We are all the beneficiaries of the building blocks put in place by previous generations of members to create the strong financial legacy that created the Foundation. This Foundation is now on a path to become an even more generous benefactor to the people who need our help, across the length and breadth of Victoria.

In June 2018, George Sutherland and Dr John Maynard retired as members of the Foundation due to their terms of office coming to an end. Thank you for your dedication and service to the Foundation.

As Grand Master of Freemasons Victoria I salute all the members of our fraternity, in giving as generously and by their daily approach to practising universal charity and living up to **our vision of making the world a better place.**

CHAIRMAN'S REPORT

In November 2018 I was appointed Chairman of Freemasons Foundation Victoria and I thank the members of the Company for appointing me to this role. I also thank and congratulate my predecessor, Andre Clayton for his tireless work throughout his term as Chairman.

A number of Directors have left the Foundation due to their respective term in office coming to an end. To Andrew Dexter, Ted Finch, Jane Hill, Dr George Streitberg and Carol Scholes-Robertson thank you for your dedication, commitment and professionalism. Your contributions were significant.

The Foundation has also welcomed Garry James, Rodney Lavin and John Patterson as Directors to the Board.

A review of the Foundation structure was undertaken, and opportunities identified to raise our level of governance and accountability with the view to long term sustainability and to identify opportunities to further grow our corpus. One outcome of that review was to increase the responsibility and levels of accountability in decision making that rests with the Executive Officer. It was also the view of the Board that a more contemporary approach to our business was essential to increase our service delivery capability. As a result of those discussions the sub-committees were discontinued. To everyone who was involved with the various sub-committees you have my heartfelt thanks.

You all gave freely and very generously of your time. Your professionalism, wise counsel and commitment is a testament to your character and reflects the true philosophy of Freemasonry. You should feel rightly proud of your achievements.

During the 2018-2019 year, the Foundation distributed \$2.7m to not-for-profit organisations and \$432k to assist students to reach their potential, taking the total amount distributed since November 2014 to \$10m.

Notable highlights during the year include the one-off Freemasons Community Grant Program where \$821k was distributed to not-for-profit organisations and the announcement of \$500k philanthropic gift over 3 years to Entertainment Assist.

In April the Foundation held a scholarship presentation for Tertiary recipients where over 150 people attended. Since 2015, the Foundation has distributed \$1.5m to students as part of its annual Scholarships and Awards program.

In June, the Board approved our Strategic Plan for the next 3 years. The plan outlines our objectives to continue supporting the Victorian community with our granting as well as to grow the corpus. An overview of the plan is included in this report whilst a copy of the document is available on our website.



The earnings from our corpus enable us to continue our granting into the community and to conduct our business. With the support of our investment advisor and donors we can make a real difference to many live across Victoria.

Finally, I thank Neil Cripps in his role as Executive
Officer and Jacintha Chiang for the administration of our
business. The fortunate position the Foundation finds
itself in today is no mean feat and you both
played a significant role in achieving those outcomes
and in assisting and supporting the community of
Victoria.








OUR STRATEGY 2019 -2022

Our 2019-2022 Strategic Plan reaffirms our mission and core values while offering an evolved, overarching goal to help guide our decision making going forward.

Through the execution of our Strategic Plan, Freemasons Foundation Victoria will continue the objectives of granting into the community whilst sustaining and growing the Foundation's corpus into the future.

Our objectives and strategies do not stand alone but are designed to reinforce and strengthen each other across our mission priorities creating a more targeted impact in our philanthropic giving.

Granting into the Community



Since our establishment in November 2014, the Foundation has provided significant grants to major community projects, particularly within the health sector. Some of those projects include Monash Children's Hospital, Mercy Health Werribee, Northern Health, Australian Prostate Centre and Think Pink Foundation all of which continue making substantial impact into the health and wellbeing of the community.

As a maturing organisation, it is appropriate for the Foundation to undertake a review of current practices and adopt a more sophisticated approach in its granting.

Education Support



Since 1912, Freemasons have been awarding Victorian Masonic Scholarships. As part of our ongoing support to the youth of Victoria we will be reviewing our scholarship and awards program with the aim of providing more opportunities for underprivileged/disadvantaged students to be supported and develop relationships with educational institutions to support the Foundation Scholarship Programs.

Corpus Growth



The Foundation Board is charged with governance over a corpus exceeding \$50m. Preservation and growth of the corpus is challenging but essential to the continuance of our philanthropic activities. These growth strategies include:

- ▶ Policy Development robust governance model to protect and grow Corpus
- ► Funding Allocations cap granting to 4% of net assets
- ▶ Bequest Program develop and implement a bequest program
- ► Named Sub-Funds launch named sub-funds



Resourcing the Foundation

The Foundation office will relocate to new premises 2019/2020. This will afford opportunity to review current workplace policies and practices, staffing requirements into the future, the Foundation governance model and overall legislative compliance.

OUR METHOD OF SUPPORT

1. Granting into the Community

Lodge Support Granting

This is the cornerstone of our philanthropic giving. Whenever possible Victorian Craft Lodges will be supported in their local community charitable works with not-for-profit organisations of a charitable purpose in the areas of Education, Health/Medical Research, Community Development, Youth Development Programs and Indigenous Programs.

Community Grants

Available to not-for-profit organisations to apply directly to the Foundation to support a specific project or part of a project for programs and initiatives in the areas of Health/Medical Research, Community Development, Education and the Arts. Grants may be for one to four year durations up to \$50,000 pa.

Major Impact Grants

Designed to support/contribute to substantial projects in Victoria. One-off grant over a specified number of years. The grant range is between \$250,000 - \$500,000 in the areas of Health/Medical Research, Education, Community Support and Indigenous Programs.

Financial Assistance

The provision of financial relief to current members of Freemasons Victoria and their dependants or former registered members of Freemasons Victoria and their dependants who are in financial need or require other support which cannot be provided by Government or other agencies.

2. Education Support

Masonic Education

Supporting Victorian Craft Lodges with their local community scholarships, bursaries and awards for primary and secondary students.

Scholarships and Awards Program

Available annually to secondary students and 1st year tertiary students taking into consideration the students result, financial need or difficulties, school and community activities.

Bursaries

Assist tertiary students requiring financial support to complete their studies.

LODGE SUPPORT GRANTING

During the year Freemasons Foundation Victoria supported many Lodges, Districts and Masonic organisations with their charitable works within the community.

Freemasons Foundation Victoria matches funds raised and in some cases, provides additional funding to support local community projects. This year, 116 applications were approved and over \$860,000 was distributed under our Lodge Support Granting program.



Freemasons Supporting the Local Community

Victorian Freemasons raised \$150,000 for Northern Health and Taralye at their Gold & Black Ball fundraising event in November 2018. With an additional \$150,000 from the Foundation, Northern Health purchased equipment for their new paediatric high dependency unit whilst Taralye erected shade sails in their playground.

- Wimmera Cancer Centre in Horsham received \$150,000 to fit out an Oncology & Chemotherapy Room and Consulting Room after receiving applications from Wimmera Lodge.
- Freemasons from Monash Gully District provided \$45,000 ongoing support to Interchange Outer East Sibling Program. The funding allows the program to continue the support of siblings of disabled children by providing after school activities and camps.
- ► Community Support Frankston received a grant of \$3,000 after an application from Lodge of Honour.
- ► Lodge of Australia Felix, presented \$1,000 to Eastern Emergency Relief enabling the purchase of food and bedding for their emergency relief programs.
- ► Lodge of Rapport presented \$1,000 to Waverley
 Benevolent Society to provide Christmas hampers
 to families and individuals in need
- ▶ Diamond Valley Foodshare received \$2,500 from The Revival Lodge in Greensborough to assist with the provision of food hampers in the local community.
- ► Hope Bereavement Services received \$4,000 from Geelong Lodge of Unity and Prudence to assist with their counselling services of grieving parents who have lost their children to sudden death.

► Freemasons from SEAVIC Lodge, Lodge of the Golden Fleece and Lodge Evolution combined to donate \$30,000 to St Mark's Community Centre in Fitzroy. The centre provides a range of support to people in need.



- Lodge Fraternal donated \$6,000 to Impact for Women to assist women and children fleeing violence in the home.
- Bayside Freemasons combined to raise \$19,500 to provide Christmas food hampers for families in need in the local area
- ► Freemasons Foundation Victoria and Cobram Lodge combined to grant \$57,500 in support of the construction of Cobram Community Cinema for use by the local community.
- ► Surf Lifesaving Lakes Entrance received \$3,621 from Gippsland Lakes Lodge to purchase sun shelters.

- Lodge Fraternal donated \$3,000 to Chevra Hatzolah
 Melbourne enabling them to purchase a defibrillator.
- Tallangatta Health Service received \$15,825 from Benambra Lodge allowing them to purchase a Semi-Automatic External Defibrillator for their Urgent Care Room.
- ▶ Ballarat Health Services received \$10,000 from Sturt-Buninyong United Lodge to purchase an iStat Machine for the Maternity Unit. The equipment enables a baby's blood sample to be taken and analysed on the ward and provide a time critical result.
- Girl Guides in Bacchus Marsh received \$2,400 to purchase camping equipment resulting from a matching fund application from the Duke of Abercorn Lodge.
- Freemasons from Elrona Lodge and Lodge Killara in Greensborough combined to support Kalparrin Early Childhood Prevention Program with a grant of \$11,000 to purchase furniture for use of primary school children using their service.
- ➤ St Mary's College for the Deaf in Wantirna received \$10,980 from The Spring Vale Lodge toward the purchase Soundfield Equipment to support students with hearing difficulties.

► The Foundation joined with Monash Lodge donating \$10,000 to Very Special Kids.



- ► The Foundation supported Lodge of Australia Felix in providing \$1,500 to Cleff Palate and Lip Society to purchase feeding equipment.
- ► Hepburn Health Service received \$7,000 from All Nations Lodge in Clunes to assist with their emergency relief program.
- ► Freemasons from Lodge of the Great Ocean Road continue to support the local community by donating \$1,500 to support Anglesea and Aireys Inlet Foodlink and Torquay Food Aid.
- Koo Wee Rup Masonic Lodge contributed \$1,000 to Koo Wee Rup Secondary School to assist with the purchase of text books.
- Morwell SES received \$2,900 from Traralgon Lodge allowing the purchase of a Defibrillator.

- Portland Lodge provided ongoing support to students attending Heywood and District Secondary College and Portland Secondary College with \$25,600 to assist students with various programs.
- ▶ Bendigo Chinese Association Museum received \$5,000 from Golden and Corinthian Lodge supporting the purchase of a new dragon.



- ► Lodge Belvoir provided \$1,000 to 1st Baranduda Scout Group towards the purchase of a trailer.
- Austin Health received \$4,225 from Baxter Lodge to purchase furniture for the Psychological Trauma Recovery Unit.
- ► Swan Hill Lodge donated \$8,000 to Swan Hill District Health to support local health initiatives.
- ► Mallee Family Care received \$1,500 from Mildura Lodge to assist local families in need.

ALFRED HOSPITAL

Freemasons from Lodge Fraternal with support of Freemasons Foundation Victoria donated \$50,000 to The Alfred's Father's Day Appeal enabling the hospital to purchase 10 Vital Sign Monitors.

The equipment has enabled better care for patients at the bedside with the impact already being experienced. Amy McKimm, Executive Director of Information Development, shared examples of the impact that Freemasons have helped achieve:

- ▶ With easy access to our patient's record wherever they are, we have seen a significant drop in the time taken "looking for a patient's record" (which could have been up to 45 minutes a shift for a nurse).
- ▶ Following implementation, we have had a few instances where there has been a national drug shortage. The system allowed us to immediately find all patients on the drug and swap them to another appropriate medication. Previously this would have involved reviewing individual drug charts, and with over 800 patients in our care this was extremely time consuming.
- ▶ With the computer at the patient's bedside, every consultation becomes a teachable moment, supporting medical staff to inform patients by talking through their results and showing them x-rays.

FREEMASONS SUPPORTING THE LOCAL COMMUNITY

Victorian Freemasons and Freemasons Foundation Victoria combined to donate \$176,000 during the year to support organisations assisting families in time of need.

Let's Talk Foundation in Warrnambool received a donation of \$41,000 raised as part of Freemasons Victoria Grand Masters Appeal after the March 2018 bushfires in South West Victoria plus an additional \$13,000 from the Foundation to employ a Community Education Officer to develop, facilitate and deliver health programs to people impacted by the bushfires.

At the United Grand Installations Banquet in May, the Foundation contributed \$15,000 towards donations of \$10,100 to the Rotary Club of Bairnsdale Farmers Relief Program and Foodbank Victoria.

The funds donated to the Farmer Relief Program has allowed the Rotary Club of Barinsdale to continue their support of East Gippsland families affected by the drought by supplying much needed stock feed, food supplements and shopping vouchers.

Applications submitted by Freemasons from Gippsland East District led to the approval of two grants totalling \$100,000 to support local farmers affected by the Gippsland drought.


A request from the Burgundy Ladies Association also saw a further \$2,000 donated to Gippsland Farmer Relief in Traralgon for the purchase of supplies for food aid hampers.

SUPPORTING EDUCATION

Since November 2014, the Foundation has contributed nearly \$2.0m to assist the youth of Victoria to achieve their education goals by:

- Our annual Scholarship and Awards Program;
- Supporting Lodges with their local community scholarships, bursaries and awards;
- ► Bursaries to assist tertiary students requiring financial assistance; and
- ► Tertiary scholarships.

The Foundation remains committed to supporting individuals in reaching their potential and continues to review our education support programs to assist secondary and tertiary students.



Scholarships and Awards

The scholarships and awards are for students in secondary education and first year tertiary education.

The secondary school awards for years 7 to 10 are for one year, whilst year 11 awards are available for 2 years subject to satisfactory completion of year 11. In addition, there are year 12 awards available for one year.

The first year tertiary education awards available to students include:

- ► Freemasons Foundation Victoria Scholarship which is tenable for the duration of the undergraduate degree and is valued at \$10,000 per year;
- Sydney George Manefield Residential Scholarship which is tenable for 3 years and is valued at \$5,000 per year; and
- ► Freemasons Post-Secondary Education Awards which are available for one year.

In 2019, 143 students were awarded a scholarship with the total amount paid being \$336,000.

Lodge Scholarships and Awards

During the year 46 applications were received and approved from Victorian Lodges to support their local community scholarships, bursaries and awards for primary and secondary students.

Freemasons Foundation Victoria matches funds raised and, in some cases, provides additional funding to support these awards given to local students. In 2018-2019, the total amount distributed was \$53,700.

In 2018-2019, 4 students attending Marysville Primary School, Middle Kinglake Primary School and Strathewen Primary School were awarded \$500 each. These awards were established by Freemasons Victoria after the Black Saturday fires in February 2009.

Bursaries

Bursaries are available to Post-Secondary students undertaking their first Tertiary Course who require financial assistance to continue their studies. In 2018-2019, the total amount distributed was \$17,000.

Tertiary Scholarships

During the year the Foundation supported 4 students by establishing scholarships in Agriculture/Agribusiness at La Trobe University, Longerenong College, Marcus Oldham College and The University of Melbourne.

Each scholarship of \$5,000 for one year was awarded to a student entering the final year of their course or commencing an honors year. The scholarships are part of a 3 year commitment to support students studying an agricultural course at a Victorian tertiary institution



COMMUNITY GRANTS

During the year, over \$1.0m was distributed to not-for-profit organisations to support a specific project or part of a project as part of our Community Grants Program. Since November 2014 Freemasons Foundation Victoria has contributed in excess of \$4.0m under this program.

Some of the funds distributed this year were part of our ongoing commitment to Monash Health and Werribee Mercy Hospital.



Organisations supported during the year include:

► A \$30,000 grant to Monash University to purchase video conferencing equipment to provide disadvantaged Victorians access to legal advice from Monash University Community Legal Centre.

► A \$500,000 grant over 3 years to Entertainment Assist to provide ongoing mental health programs for people working in the Australian performing arts and entertainment industry.



- ▶ A \$25,000 grant to Melbourne Symphony Orchestra to assist in the cost of their 2019 Regional Tour. The regional tour will perform in Warragul, Wangaratta, Shepparton, Ballarat, Bendigo, Horsham, Hamilton and Warrnambool. As part of the Regional Tour the orchestra will also perform concerts at local primary and secondary schools.
- ▶ \$80,000 grant to Victoria Police Blue Ribbon Foundation towards a \$680,000 project for the installation of a Critical Circulatory Support Service at Eastern Health's Box Hill Hospital.
- ► A \$200,00 grant over 2 years to Gather My Crew who provide a free online rostering tool that connects people going through a tough time with family and friends who want to help.

A \$30,000 grant was provided to State Schools Relief providing support for approximately 407 students across Victorian state schools. The funds were specifically used as part of the 'Affordable School Uniforms' program which provides school uniforms and other essential educational items for students in need.



As part of the \$1.8m commitment over 6 years with Monash Health, the third instalment of \$300,000 was paid in December. Since 2016, the hospital has purchased the following medical equipment for the provision of dedicated paediatric services to the Victorian community.

- ▶ 2016 Zeiss OPMI Pentero Microscope.
- ▶ 2017 Urodynamics Machine and Image Intensifier,
- ▶ 2018 Mobile Xray, Vascular Ultrasound and Portable EEG.

FREEMASONS COMMUNITY GRANTS

In August 2018 a one-off program was launched for Victorian Craft Lodges to apply for a \$5,000 grant for local community charity projects.

166 sucessfully applied for a grant. A total of \$821,228 was distributed.



The result was impacted by the one-off Freemasons Community Grant program, in which the Foundation distributed \$821k to local not-for-profit organisations.

3 named sub-funds have been created to provide an enduring gift. Funds received totalled \$94k.

As at 30 June 2019, the Foundation had \$54.1m of funds under management. These are administered by JBWere.

One of the key responsibilities of the Board is the monitoring of the investment activities via a robust Investment Policy with the objectives including:

- ► Invest in a manner that provides a level of return to fund the mission, objectives and purpose of the Foundation, its outgoings and build a legacy for the future; and
- ▶ Manage risk though prudent financial management and diversification.


